To Whom It May Concern,

My name is Kyle Bryant from the Law Offices of Goodman Hurwitz & James, P.C. On March 20 of this year, our office sent a FOIA request on behalf of the Coalition for Police Transparency and Accountability for all the BOPC packets from meetings held in January and February of 2024. On March 21, 2024 we received an automatic response stating that “staff that will get in touch with you soon”. On May 16, 2024, I sent a follow-up inquiry about the status of this request. We have yet to receive any response from your office since your initial automated response that I received on March 21, 2024.

Additionally, on May 16, 2024, my office submitted two additional FOIA requests: 1) all BOPC packets from meetings held in March and April of 2024; and 2) all closed CCR files from March and April 2024. We have received absolutely no response at all from either your office or from the BOPC.

Please provide the status of the above-described three (3) outstanding FOIA requests as soon as possible.
